Members of Levi Water Supply Corporation:

The annual meeting for the members of Levi Water Supply Corporation is scheduled for April 23, 2024. The annual meeting will include the annual financial report, budget, and an overview of the operations for 2023, an overview of recently completed improvements, improvements in progress, planned improvements (current & future), regulatory changes and challenges for the water industry in Texas.

Levi Water Supply Corporation is a non-profit, member owned, rural water supply corporation, originally incorporated in 1964.

Levi Water Supply Corporation bylaws allow for five Levi Water Supply members that reside on the Levi Water Supply system to serve as a director on the Board of Directors. Each board member is elected to serve a three year term. The Levi Water Supply Corporation Board of Directors is responsible for the financial and managerial practices of the water system; insuring the compliance of standards and guidelines that are mandated by federal, state and local regulatory agencies; establishing an operating budget and reviewing the rate structure. The board members serve without any compensation.

The Board of Directors meet on a monthly basis. A board member can't miss more than three non-consecutive meetings without good cause. It is imperative that directors become familiar with the regulatory and environmental issues mandated by the regulatory agencies, the operational rules of water systems that include financial management, and the continuous process of promoting conservation.

The term for Chris Miller and Gayle Richey will expire this year. After the annual meeting, there will be a board meeting to elect the officers of the board for the next year.

The election procedures are adopted in accordance with Sections 67.0051 - 67.0054 and 67.007 of the Texas Water Code. If you are interested in serving as a board member and would like your name to be placed in nomination, you may pick up or request an application packet from the Levi Water Supply Office at 2757 Rosenthal Parkway, Lorena, Texas.

To serve as a board member, A Levi Water Supply Corporation board member is defined as a property owner that has their primary residence in the boundaries of Levi Water Supply and receives their water service from Levi Water Supply. Additional qualifications to serve as a board member are included in the application package. Current board members can continue to serve, subject to complying with the election guidelines.
